Your declaration covers any donation you are kind enough to make to us in the future and for the four years prior. Therefore please notify us if you change your name or address. You can cancel this declaration at any time by letting us know in writing. You may need to do this if your tax status changes. If you pay tax at the higher rate, you can claim further tax relief in your Self-Assessment tax return.

The Gift Aid scheme enables us to claim back any tax already paid on a gift of money, no matter how large or small. Subject to a few rules, you can give Practical Action a sum of money, either as a one-off gift or as part of a regular payment, and we can reclaim the tax. Using Gift Aid means that for every pound you give, we get an extra 25 pence through HM Revenue and Customs. This means that £10 can be turned into £12.50 as long as donations are made through Gift Aid. Imagine what a difference that could make and it doesn't cost you a thing.
