#### **ABOUT THE PROJECT**

The United States Agency for International Development (USAID) Bureau for Humanitarian Assistance(BHA) works to save lives, alleviate human suffering, and reduce the impact of disasters by helping people in need become more self-reliant. BHA is responsible for planning, coordinating, developing, achieving, monitoring, and evaluating international humanitarian assistance falling into two conceptual areas: 1) humanitarian response during emergencies and 2) Early Recovery, Risk Reduction, and Resilience (ER4) activities to address longer-term recovery after emergencies.

USAID has announced Round o4 - Nepal Early Recovery, Risk Reduction, and Resilience (ER4) Activity whereby it focuses on enhancing the disaster management capacity of the Government of Nepal (GoN) and the highly vulnerable, disaster-prone communities, empowering them to reduce risks and improve their ability to mitigate, withstand, respond to, and recover from disasters.

The position of Emergency Preparedness and Response Manager has been advertised in anticipation to serve the above mentioned activity.

#### **JOB PROFILE**

#### **Purpose, Scope and Relationships**

**The purpose of the** Emergency Preparedness and Response Manager is to lead strategic decisionmaking to leverage resources from USG and non-USG programmes in Nepal, enhancing local preparedness and resilience to recurrent disasters. In the event of a disaster, they will guide technical, multi-sectoral analysis and response design.

**The scope is to be responsible** for the overall disaster risk reduction and response function of the project and liaise with humanitarian coordination groups to advise Nepal's National Disaster Risk Reduction and Management Authority to ensure coordinated and effective responses in targeted provinces.

**The key working relationship is** with the project team and will develop close working relationships with the Country Management Team, Thematic Lead – Climate and Resilience, Programme Managers, Global Thematic Team and any other relevant Regional Teams. The role will engage with relevant technical teams including consultants.

#### Job Functions and Responsibilities

- Collaborate with the Chief of Party (COP) to develop strategies for community-level disaster planning, response, and early recovery, ensuring that the approach is contextually relevant and meets project objectives.
- Lead the execution of the technical strategy for disaster preparedness and response, ensuring it aligns with project objectives, quality standards, and adapts based on learnings and evolving contexts.
- Integrates approaches such as locally driven, shock-responsive, climate adaptive, socially and gender-inclusive, youth empowerment, and nutrition-sensitive methods into the design of disaster preparedness and response activities.
- In collaboration with the M&E team, implements a framework for assessing the effectiveness of multi-sector disaster preparedness and response efforts, conducting regular disaster risk assessments and adjusting strategies based on changing environmental conditions.
- Identifies and promotes opportunities to incorporate technology, such as mobile apps for alerts and GIS mapping for vulnerability assessments, to enhance disaster preparedness and response.
- Ensures all interventions adhere to Practical Action's Policies, Do No Harm principles, programme participant accountability standards, and programme management minimum standards.
- Lead the recruitment, onboarding, and supervision of the technical staff for the disaster preparedness and response components of the project.
- Foster a culture of mutual respect, collaboration, curiosity, learning, and adaptation within the team, ensuring that all voices are heard in developing shared strategies.
- Provide team members with the necessary tools, resources, and support to enhance their technical skills, improve performance, and achieve objectives. Conduct regular one-on-one meetings and performance reviews, ensuring accountability and offering constructive feedback.
- Represent Practical Action and the Project in humanitarian coordination groups and relevant working groups to ensure effective communication and coordination.

- Provides advisory support to Nepal's National Disaster Risk Reduction and Management Authority, ensuring a coordinated and effective response in the targeted provinces.
- Cultivate partnerships with government bodies, NGOs, civil society, and private sectors to support a coordinated approach to disaster risk reduction, planning, and management.
- Actively contribute to and collaborate with country, regional, and global counterparts, driving collective impact, sharing learning, and enhancing program visibility.
- Ensure that partner activities comply with grant agreements, Practical Action policies, and relevant regulations, including USAID and GoN requirements.
- Support systems to ensure the efficient, transparent use of financial resources, ensuring timely and accurate reporting in line with program, donor, and Practical Action's requirements.
- Supervise a team of direct reports, with the specific number of direct and indirect reports that will be determined at a later stage.
