ABOUT THE PROJECT

Kenya is undergoing an energy transition to achieve its climate commitments and development goals, such as universal access to sustainable energy by 2030 and Net Zero emissions by 2050. Despite significant strides in renewable energy deployment and policy reforms, gaps in energy planning remain. These include fragmented coordination between national and county governments, inadequate data management systems, and limited county-level institutional capacity. These challenges hinder the development of the Integrated National Energy Plan (INEP) which addresses Kenya's energy needs while promoting social equity and environmental sustainability.

A consortium led by **Practical Action**, **Strathmore University**, and **KTH Royal Institute of Technology**, is undertaking a project to develop County Energy Plans (CEPs), Energy Policies, and Investment Prospectuses for 5 counties: Homabay, Murang'a, Siaya, Tharaka Nithi and Kajiado County. Over 12 months, the project will enhance institutional capacity for gender-responsive, inclusive energy planning, equipping counties with data-driven policies and investment strategies to attract financing and improve energy access.

Counties were selected based on their lack of energy plans, active energy departments, geographical representation, marginalized populations, and political willingness for implementation. The structure,

adaptive methodology ensures alignment with the Integrated National Energy Planning (INEP) framework, the Public Policy Guideline Handbook (2024), and best practices in investment planning. It incorporates evidence-based decision-making, stakeholder engagement, and Gender Equality, Disability, and Social Inclusion (GEDSI) principles to ensure that energy needs of vulnerable communities are addressed.

The consultant will lead a team of staff from Practical Action, MoEP, selected counties and community members to undertake legal compliance & Public participation Engagement. The project will run for 12 months with a key focus on strengthening county-level energy governance, guide investments, align with national frameworks, and contribute to sustainable development, attract financing and improve energy access.

The project will deliver impactful climate action by enhancing technical capacity improving governance frameworks and creating investment ready plans, The initiative directly supports Kenya's clean energy transition. It contributes to reduced greenhouse gas emissions, improved energy security and creation of green economic opportunities.

In this regard, Practical action is seeking the services of a consultant to support five counties (Homabay, Siaya, Tharaka Nithi, Murang'a, and Kajiado) to ensure the development of legally sound, participatory, and institutionally aligned county energy products.

PURPOSE OF THE ASSIGNMENT

The purpose of this assignment is to provide legal, procedural, and public participation advisory support to guide the development of CEPs, IPs, and EPs. The consultant will develop frameworks, tools, and advisory inputs that strengthen legal alignment, legislative engagement, and public participation processes, thereby supporting counties to position the plans for consideration and adoption by County Governments.

SPECIFIC OBJECTIVES OF THE ASSIGNMENT

1. Provide Legal Advisory and Compliance Guidance.

Offer legal advisory inputs to guide CEPs, IPs, and EPs toward alignment with:

- The Constitution of Kenya
- Energy Act 2019
- Public Policy Handbook (2024)
- INEP Regulations (2025)
- County Governments Act
- PFM Act and county budgeting cycles

- Other relevant national and county legal frameworks

2. Strengthen and Facilitate County Legislative Engagement

Provide both structural and operational support to legislative processes by:

- Developing practical frameworks, process maps, and guidance documents outlining legislative pathways for CEP, IP, and EP consideration.
- Clarifying the required steps for County Executive and County Assembly processing, including the roles of the County Attorney, Clerk, and Assembly Committees.
- Preparing briefing notes, issue papers, explanatory memos, and communication materials to support legislative understanding.
- Advising counties on committee processes, motion development, and Assembly expectations.
- Facilitating constructive engagement and relationship-building between counties, technical consultants, and legislative offices to support smooth progression through legislative processes.

3. Guide Legally Compliant Public Participation

Guide counties in designing and implementing public participation plans and tools that meet constitutional, statutory, and county-level requirements, ensuring inclusion, transparency, and broad stakeholder ownership.

SCOPE OF WORK

The Consultant will undertake the following tasks:

1. Inception and Planning

- Holding introductory meetings with the project team and county leads to understanding context, timelines, and expectations.
- Prepare an inception report outlining the methodology, timelines, and engagement approach.
- Conduct county-specific stakeholder mapping, including County Assembly committees, County Attorneys, Clerks, and other legislative actors.

2. Legal Compliance Review

- Review relevant national frameworks, including the Constitution of Kenya, Energy Act, INEP Regulations (2025), PFM Act, County Governments Act, and other applicable sectoral laws.
- Review county-level legal frameworks, including enabling legislation, policy development procedures, and decision-making processes.
- Identify legal risks, compliance gaps, and procedural inconsistencies that may affect CEP, IP, or EP adoption

3. Legislative Engagement Support

- Develop a structured approach and guidance for engaging County Assemblies, County Attorneys, and legislative committees.
- Prepare briefing notes, explanatory memos, issue papers, and other materials required to support legislative understanding of CEPs, IPs, and EPs.
- Support the project team and counties to conduct targeted engagements with legislative offices and relevant committees.
- Provide advisory support on committee processes, motions, resolutions, and procedural expectations.

4. Public Participation Design and Support

- Develop county-specific public participation frameworks that align with constitutional, statutory, and county-level requirements.
- Provide templates for notices, invitations, facilitation tools, reporting templates, and compliance checklists. Support county teams during public participation events (physical, virtual, or hybrid) by offering technical guidance on process, documentation, and inclusion requirements.

5. Legal Review of Draft County Energy Products

Provide annotated legal advisory notes on draft CEPs, IPs, and EPs, focusing on legal structure, wording, compliance, and procedural alignment.

- Advise on integration of the products with CIDP, ADP, sector plans, and county legislative pathways.

6. Consolidated Reporting.

Prepare consolidated outputs and reports summarizing:

- legal compliance status for each county.
- alignment with legislative pathways.
- public participation outcomes and documentation quality.
- identified risks and recommendations.
- next steps for submission, consideration, and adoption.

NOTE: The outcome of each delivery shall be presented to the technical working group and approved. It is expected that there will be adequate stakeholder engagement at each stage of the process to ensure that all forms of feedback are incorporated.

REQUIRED QUALIFICATIONS AND EXPERIENCE

- Ability to produce high-quality legal and policy documents
- Strong communication and facilitation skills

GUIDELINES FOR SUBMISSION OF APPLICATION

- 1) A technical proposal detailing interpretation of the TOR, proposed methodology including sampling framework, work schedule and deliverables etc.
- 2) A capability statement demonstrating how the consultants meet the required qualifications and competencies.
- 3) Copies of all relevant Curriculum Vitae (CVs). Only CVs for the specific individuals that will form the proposed survey team should be included; two references (including one from your last client).
- 4) Detailed financial proposal in Kenyan Shillings: If the team consists of several members, the professional fees should not just be a daily rate, but it should be based on clearly shown time allocation by each member of the team to the various activities.
- 5) Evidence of experience in similar work
- 6) Mandatory statutory documents and tax compliance certificates
